PRE-EXECUTION CHECKLIST GUIDE

The following is a Standard Operating Procedure for filling out the Army School System (TASS) Unit Pre-Execution Checklist, TRADOC Form 350-18-2-R-E dated JUL 2009.

- 1. Block 1: Soldier's Last name, First name, Middle Initial in that order
- 2. Block 2: Soldier's Social Security Number
- 3. Block 3: Soldier's Full Unit
- 4. Block 4: Soldier's Date of Rank
- 5. Block 5: "AIR DEFENSE ARTILLERY ALC"
- 6. Block 6: Report Date

Part I of the Unit Pre-Execution Checklist (D-90 to D-1)

This form is to be filled out by the soldier and the First Line Leader. It is the First Line Leader's responsibility to ensure verification and receipt of all required documents and equipment to attend the course. Both the Student and the First Line Leader must initial this portion to verify all prerequisites are complete.

IMPORTANT HOT ITEMS!!:

APFT:

SM must take an APFT 30 days prior to attending NCOES

SM meets standards of AR 600-9:

If SM does not pass the second body fat screening given by the NCOA, SM will receive a "Marginally Achieved" on their DA 1059

Transportation:

NCOA does not provide modes of transportation and the unit must ensure SM has a mode of transportation to and from training. NCOA advises SM not to schedule flights home on the day of graduation; the last flight out of Lawton is usually 1800.

Individual has current Periodic Heath Assessment (PHA)

Reference Regulation AR 40-501 Para 8-19 (3): ALL PERSONNEL ON ACTIVE DUTY WILL UNDERGO A PERIODIC EXAMINATION WITHIN 3 CALENDAR MONTHS BEFORE THE END OF THE BIRTHDAY MONTH, AT AGES 30, 35, 40, 45, 50, 55, 60, AND ANNUALLY THERAFTER. Soldiers must have an exam prior to attending a NCOES course, failure to do so will result in a denied enrollment.

Unit POC List:

It is crucial to the success of the NCO while they are in the course that the Academy chain of command is able to contact the NCO's chain of command at any time. The POC list must filled out completely to include all phone numbers, both work and home. The unit FAX number is also crucial in case the soldier has not brought the required documentation so the unit can FAX the missing paperwork. Finally, if all conventional communication fails it will be necessary to contact the chain of command by means of email.

Military and Civilian Vehicle Operator Permit: NCOs reporting to ADA ALC are not required to bring their DA Form 348 and OF 346.

PART III REQUIRED DOCUMENTS

Security Clearances: The following MOSs must have proof of Security Clearance SF 83 or Letter from Unit S-2: 13F, 13P, 13D, and 13R.

Permanent Profile attendees (if applicable): AC and AGR must have a copy of MRB (P3, P4) results with completed DA Form 3349 (must include Army doctor-approved alternate aerobic event for APFT). TPU/Traditional Guardsman must have a completed DA Form 3349 (must include Army doctor-approved aerobic event for APFT).

Student Signature: Student Signs that they have read, understood, and complied with all necessary documentation and course prerequisites and is able to attend the course.

Commanding Officer Signature: Commanding Officer has reviewed the NCOs packet to ensure completeness. Also the commander has identified that the NCO meets all qualifications and potential to successfully complete this course; and have counseled him/her on the requirements and hereby verifies his/her readiness to attend the course. Commander must have Assumption of Command orders if they are not an O-03.

Most recent copy of ERB Copies of all Previous 1059s (Academic Evaluation Report) for all NCOES Courses attended Copy of DA Form 3349 (Physical Profile) if applicable Copy of Current Physical if not updated on ERB Copy of Valid Security Clearance if applicable (DA Form 873) 5 copies of orders assigning you to the NCOA Academy If SGT in a promotable status, must bring updated copy of C10 Roster to verify you are on the promotion standing list.
