- (1) https://themilitarywallet.com/military-retirement-pay-cola-increase/. The cost-of-living adjustment for 2023 will be 8.7% for Social Security checks, VA disability compensation and other government pension and benefit programs. COLA raises for Social Security benefits and certain other benefits are automatic. However, each year Congress must pass a bill to implement COLA raises for veteran benefits, including disability and dependent compensation, clothing allowances and dependency and indemnity compensation. Military retirement pay COLA increases take effect in your January 2023 payment.

- (2) https://www.militarytimes.com/veterans/2022/12/29/new-in-2023-pact-act-processing-set-to-start-jan-1/. I marks the first day VA officials can officially begin processing all claims related to the Promise to Address Comprehensive Toxics Act better known as the PACT Act. Since the end of last summer, more than 176,000 veterans have submitted paperwork related to military toxic exposure issues covered in the measure. Veterans who believe they may be eligible for new healthcare services or benefits can visit VA.gov/PACT or call 1-800-MYVA411 (1-800-698-2411) for additional information.
