- SGM (Ret.) H.E. McClure: Reynolds Army Health Clinic (RACH) stated that there will not be flu shots.
- Mrs. Patricia Cameron: Case Lot Sale will not be a part of the RAD; Case Lot will be from 22 – 24 September 2022.
- Mrs. Cameron contacted Garcia DFAC – Retirees can eat there with ID Card for \$6.85; hours of operation are 1130 – 1300.
- CSM Taylor also stated that the Guns & Rocket DFAC is available in the 75<sup>th</sup> Brigade area.

As part of the Army Retiring Soldier Commendation Program (ARSCP) Package, IMCOM will continue funding US Flags. IMCOM is working a supply issue and is participating in a working group led by HQ DA. Because of inflation, the costs to purchase the flags have increased from \$13.95 to \$20.88.

The next retirement ceremony will be 16 September 2022, 1500, at the Cache Creek Chapel Complex, with 14 Soldiers and 2 Civilians attending.
