- 2. Policy. I am committed to the Army's policy of ensuring Soldiers, Family Members, and DA Civilians are provided an environment free of unlawful discrimination and offensive behavior. Discrimination will not be tolerated, practiced, or condoned at Fort Sill. Commanders and directors will create and maintain an environment conducive to maximum productivity and respect for human dignity.
- 3. Procedures.
- a. Individuals are responsible for advising their command of unlawful discrimination and providing the command an opportunity to take appropriate action to resolve issues.
- b. Anyone who believes they have been discriminated against has the right to file a complaint with their chain of command without fear of discrimination, harassment, intimidation, reprisal, or retaliation. Such reprisals are in direct violation of Army policy and will be reported immediately to the Inspector General office, (580) 442-3109, Building 1616.
- c. Although using the chain of command is strongly encouraged, it will not serve as the only channel available to the complainant. Should the complainant feel uncomfortable in filing with their chain of command, they may contact the following offices directly for assistance: Equal Opportunity, Inspector General, Religious Services, Provost Marshal, Medical agency, Staff Judge Advocate, or Housing.
