Retrieves data from vehicles and remote locations via wireless modems and through recording media. Performs preliminary data analysis and compile data recording programs through provided software. Assists and suggests sensor placement based on test procedures. Designs and fabricates custom mounting hardware for equipment and sensor installations. Works well with others and demonstrate good customer service attributes. Performs other duties as required to complete the assigned mission.
