Installs and maintains air-ground radio systems, console and fixed, mobile and portable radio units including installation in fixed sites and vehicles. Setup and installation of range communication radio systems in support of test requirements. Performs other duties as required to complete the assigned mission. This position is covered under the Collective Bargaining Agreement.

- Must be able to install radios/ antennas in tight spaces regarding vehicle installs.
- Must be tolerant of heights as some work may require the use of lift equipment such as bucket trucks.

- Must be able to work all shifts, weekends, holidays, and overtime as needed, sometimes on short notice, to support test missions.

- Must use "down-time" effectively to the benefit of test, self, and company.
- Must be punctual, responsible, and dependable.
- Must demonstrate motivation, initiative, and reliability.

- Must have a demonstrated ability to follow instructions and company policy.
- Must be able to deliver quality products to the customer and be responsive to their needs.
