# CITIZENSHIP FOR SPOUSES



# How can I obtain citizenship for my spouse?

Please refer to the U.S. Citizenship and Immigration Services (USCIS) website at https://www.uscis.gov/military/citizenship-for-military-family-members. This will provide you with up-to-date changes to the requirements for your application.

Spouses of U.S. citizen service members may be eligible for expedited or overseas naturalization and may not be required to establish any prior period of residence or specified physical presence within the U.S., which is typically required.

# How can I get Expedited Naturalization for my Spouse?

Spouses of U.S. citizen service members who are or will be stationed outside of the United States may be eligible for expedited naturalization inside the U.S.

# Requirements to Apply:

- 1. Be age 18 years or older.
- 2. Establish you are the spouse of a U.S. citizen who is or will be regularly stationed abroad as a U.S. service member for a period of one year or more.
- 3. Be authorized to accompany your spouse abroad by your spouse's official orders.
- 4. Be present in the U.S. as a lawful permanent resident at the time of your naturalization application interview.
- 5. Declare in good faith upon naturalization an intent to reside with your U.S. citizen spouse and to reside in the U.S. immediately upon your spouse's termination of service abroad.
- 6. Be able to read, write, and speak basic English.
- 7. Have a basic knowledge of U.S. history and government (civics).
- 8. Have been, and continue to be, a person of good moral character, attached to the principles of the U.S. Constitution and well-disposed to the good order and happiness of the U.S. during all relevant periods under the law.

USCIS will only accept the following documents issued by the U.S. Armed Forces as "official orders:"

Copy of Permanent Change of Station (PCS) orders issued to a service member for a permanent tour of duty overseas that specifically name the spouse or child applying for naturalization.

If the submitted PCS orders do not specifically name the applicant beyond reference to "spouse," "child," or "dependent," then the applicant **must** submit:

PCS orders (copy);

Form DD-1278 (Certificate of Overseas Assignment to Support Application to File Petition for Naturalization); and

Service member's Form DD1172 (Application for Uniformed Services Identification Card DEERS Enrollment) naming dependents.

# What if my Spouse is deployed overseas and I accompany them, can I Naturalize Abroad?

Yes, eligible spouses of service members can naturalize abroad without requiring them to return to the United States for any part of the naturalization process.

To be eligible, you **must** be:

- A lawful permanent resident (green card holder) of a service member
- Be authorized to accompany the service member abroad per the service member's official orders
- Meet the requirements of INA 316(a) or INA 319(a) at the time of filing for naturalization, except for the residence and physical presence requirements.

# How Do I Apply?

Please follow these three steps:

#### **STEP ONE: Fill Out Form N-400**

If your biological or legal adoptive mother or father is a U.S. citizen by birth, or was naturalized before you reached your 18th birthday, you may already be a U.S. citizen. Before you consider filing this application, please visit the USCIS Website at <a href="https://www.uscis.gov">www.uscis.gov</a> for more information on this topic and to review the instructions for Form N-600, Application for Certificate of Citizenship, and Form N-600K, Application for Citizenship and Issuance of Certificate Under Section 322.

NOTE: Are either of your parents a United States citizen? If you answer "Yes," then complete Part 6. Information About Your Parents as part of this application. If you answer "No," then skip Part 6. and go to Part 7. Biographic Information.

Go to **https://www.uscis.gov/n-400** download and or print out Form N-400 and fill it out in type or blank ink.

You should indicate if you are seeking to naturalize through the general provision or on the basis of your marriage to a U.S. citizen. You **must** have been **married for three years** before applying for naturalization, even if overseas. Spouses should also write in "Overseas Naturalization."

#### STEP TWO: Attach Evidence Required by Form N-400

#### **Evidence Required:**

- 1. A copy of your Permanent Resident Card.
- 2. A copy of your marriage certificate.
- 3. Evidence of your citizen spouse's employment abroad.
- 4. Two passport-style photographs (if you reside outside the United States); make sure the photographs have a white or off-white background.
- 5. Form DD-1278, Certificate of Overseas Assignment to Support Application to File Petition for Naturalization

Form DD-1278 must be completed and signed by the military official certifying the applicant has "concurrent travel orders" and is authorized to join their spouse military service member abroad.

6. Fingerprint Cards FD258

The spouse should submit two completed fingerprint cards (FD-258). Spouses applying overseas must have their fingerprints taken at a U.S. military base, an overseas USCIS field office, or an American Embassy/Consulate. Spouses applying in the United States must have their fingerprints taken at a USCIS Application Support Center.

# **STEP THREE: File your Form N-400**

You MUST attach a filing fee to your application.

Currently, \$640 but should also include a biometrics fee of \$85 for a total of \$725. You may pay online if filing your Form N-400 online; if filing by mail, you may pay by money order, personal check, cashier's check, or by credit card, but you will need to use Form G-1450.

If paying by check, you must make the check payable to the U.S. Department of Homeland Security. Do **NOT** abbreviate by using DHS.

# Where do I File my Form N-400?

You must file your Form N-400 either online; to do so, you must create a USCIS account or by mail.

**Do NOT forget to sign your form**. Unsigned forms will be rejected.
