**SUBJECT: Installation and Use of Trampolines on Fort Sill, GC Policy Memorandum 22-06**

**1. Reference.**

**2. Purpose.** Trampolines pose a very serious safety and liability issue to residents and guests. Therefore, Corvias Housing will enforce a strict policy surrounding trampolines with the intent to prevent injury and damage to government or private property. Under this policy, residents who install a trampoline are responsible for injuries that happens or property damage caused by trampolines. I expect all who own a trampoline to adhere to this policy.

**3. Policy.**

a. A written request to erect a trampoline must be submitted to Corvias Housing and approval must be granted prior to installation. Trampolines must be installed on a level surface area and be clear of overhead hazards such as roof line, trees, and power lines. Housing will not modify existing ground areas or tree canopy to accommodate a trampoline.

b. Residents who install trampolines are required to anchor them with screw type anchors and straps only because Fort Sill is prone to severe weather with high winds. The area where the trampoline is to be placed will be checked for underground utilities

prior to installation. The Family's last name will be stenciled on the legs of trampolines to identify the owner in the event there is property damage.

c. Parents and/or legal guardians will ensure that trampolines are used in full compliance with the U.S. Consumer Product Safety Commission guidelines or American Association of Orthopedic Surgeons Position Statement. All trampolines must have safety netting and meet all safety guidelines for installation as required by the manufacturer. Residents are encouraged to secure additional liability insurance to cover any injuries that may occur as a result of trampoline usage.

4. Punitive. Failure to comply with paragraph 3b of this policy will result in residents being required to immediately remove the trampoline, face possible termination from Government quarters, and/or be subject to possible UCMJ action.

5. This policy will remain in effect until superseded or rescinded.

6. This GC Policy memorandum supersedes GC Policy Memorandum, 20-06, Subject: Installation and Use of Trampolines on Fort Sill, GC Policy Memo 20-06, 21 September 2020.
